*From Florence, take I-20 South to Exit 76A onto I-77 toward Charlotte/Charleston. Merge left onto I-77 toward Charleston. Get off at the Shop Rd Exit 6-B. Drive to the end of Shop Rd, 3.4 miles and turn right onto George Rogers Blvd. At the first stop light George Rogers turns into Assembly Street. Drive .08 miles to the 2nd light and turn left on Blossom. Drive two blocks, turn right onto Lincoln Street and the Convention Center is four blocks on the left.

*From Charleston, take I-26 West to Columbia, Exit I-77 North get off at the Shop Rd Exit 6-B. Drive to the end of Shop Rd, 3.4 miles and turn right onto George Rogers Blvd. At the first stop light George Rogers turns into Assembly Street. Drive .08 miles to the 2nd light and turn left on Blossom. Drive two blocks, turn right onto Lincoln Street and the Convention Center is four blocks on the left.
