When traveling West on 526, take exit 16A, go straight through the light, follow the service road and turn left onto W Montague Ave. Follow Montague Ave and turn left onto Amsterdam Street. The Convention Center will be on your left.

When traveling on I-26 W, take exit 213A, keep left on Montague Ave and the Convention Center will be 1 mile on your right.

All exhibitors loading in and out of the facility must utilize the loading dock located at the rear of the Charleston Area Convention Center off of Montague Avenue. Parking in front of the building and using the lobby to load/unload is strictly prohibited and vehicles can be towed at the owner's expense. Once exhibitors have unloaded all materials from their vehicle, vehicles should then be moved to Parking Lot E prior to booth set-up. Prior to load-out, no exhibitors will be allowed into the loading dock until the show closes.

Please complete move-out by 1:00 PM on Monday. Any items left in the exhibit hall after 1:00 PM Monday will be removed from the building and discarded.

- 1. Exhibitor Badges will be available for pick-up during move-in on the exhibitor check-in desk near the loading docks. After the show opens on Friday, any badges not picked up during move in will be delivered to your booth by your onsite show manager.
